- To assist members of the Presidential Council and invitees to better understand their role, we have prepared a brief commentary on 'What it Means to be a Member of the Presidential Council'. This document can be accessed on the AIDA world website.
- One of the most important roles is that of the Liaison Representative for National Chapters and provision of regular reports about the activities of those National Chapters.
- 5.4 The most recent meetings of the Presidential Council have been in:
 - 5.4.1 Lisbon, Portugal, November 2010.
 - 5.4.2 Asuncion, Paraguay, April 2011.
 - 5.4.3 Tel Aviv, Israel, September 2011.
- 5.5 The proposed future meetings are:
 - 5.5.1 Istanbul, Turkey: 3-5 May 2012.
 - 5.5.2 London, England: 12-14 September 2012 in conjunction with a meeting of AIDA Europe.
 - 5.5.3 Lisbon, Portugal: May 2013 in conjunction with the Congress of CILA.
 - 5.5.4 Sydney, Australia: 18-21 September 2013 in conjunction with the National Conference of AILA.
 - 5.5.5 The Presidential Council will also meet on 29 September 2014 in Rome as part of the Rome/Florence AIDA World Congress, which will be held from 28 September to 2 October 2014.



- The structure and format of Presidential Council meetings is running quite smoothly. They follow a meeting of the Executive which gives preliminary consideration to the major issues on the Presidential Council's agenda. In most instances, the Executive is able to provide a report and specific recommendations to the Presidential Council on all major issues. This aides the efficiency of those meetings.
- 5.7 In Tel Aviv, a new feature was introduced to meetings of the Presidential Council. A significant amount of time was allocated for the discussion of a Special Issue. In Tel Aviv it was 'Lessons for a Successful National Chapter'. This format will be followed again in Istanbul where the Special Issue will be 'How to Obtain Sponsorships for AIDA Activities'.

6 NATIONAL CHAPTERS

7 AIDA BY LAWS

- Assistant Secretary-General, Tim Hardy, has successfully concluded the first part of the review of AIDA By Laws and their amendment. The amendments permit electronic meeting of National Chapters and have been used to facilitate the admission of new National Chapters without waiting for a General Assembly. The amendments also enable the admission of a second Chapter from China, given the particular circumstances of Hong Kong.
- 7.2 A second tranche of potential amendments were tabled in Tel Aviv and will be further considered in Istanbul. These include:

- 8.2 I acknowledge the considerable effort which Vice-President Eduardo Mangialardi continues to make as leader of our Working Parties.
- 8.3 In April 2011 the AIDA Working Party Rules were amended to include the following points:
 - 8.3.1 30 days after each meeting, the Working Party Chairman must send to the President (Michael Gill) and General Working Parties Co-ordinator (Eduardo Mangialardi) a report of it.
 - 8.3.2 The Chairman of the Working Party shall, at the request of the President or the General Working Parties Co-ordinator submit a written report on the Working Party's progress in the period elapsed.
 - 8.3.3 The Chairman shall appoint a Vice-Chairman of each Working Party to supplant him when necessary. Any Vice-Chairman is not, by reason of his office alone, entitled to be a member of the Presidential Council. The Chairman can also choose a Secretary who shall be responsible for the task administrator.

9 REGIONAL GROUPINGS

- 9.1 CILA (the regional grouping of the Spanish and Portugese speaking Chapters) and AIDA Europe continue to grow strongly.
- 9.2 They benefit significantly from excellent leadership and have done now for some time.
- 9.3 Following the meetings of both groupings in Paris, they have met as follows:

9.4 The Australian Insurance Law Association has formed a Regional Relationships
Committee as a first step towards the creation of a regional grouping in the Asia-Pacific
region. There is enormous scope for growth in that region which has eight existing
Chapters and six potential future Chapters, either currently being formed or in the early
stages of consideration.

ARIAS

- 9.5 Members of AIDA, or the Presidential Council, may establish ARIAS ('AIDA Reinsurance and Insurance Arbitration Societies') for the purpose of facilitating and advancing the use of arbitration as a means for the resolution of insurance and reinsurance disputes.
- 9.6 All such societies may be affiliated to AIDA as Centrally Affiliated Chapters and such Chapters shall, in accordance with and subject to such terms and conditions as may be from time to time proposed by the President and approved by the Presidential Council, enjoy and observe the rights and obligations of Members of AIDA, save that they shall not be entitled to vote at the General Assembly.
- 9.7 Branches of ARIAS exist in the following countries:
 - ARIAS USA
 - ARIAS UK
 - Europe: CEFAREA and ARIAS EUROPE
 - Mexico
 - ARIAS LATAM (inaugural meeting to be held in Santiago in April 2012)
- 9.8 ARIAS was the original inspiration of former President, John Butler. Each National Chapter of AIDA has the opportunity to form an ARIAS in their own country.



10 INTERNATIONAL LIAISONS

10.1 European Union

Close liaison at the personal level has existed for a number of years between members of AIDA and the European Union. In 2010, with the Chairman of the Finance Committee (Taisto Hujala), I paid a visit on Karel van Hulle, Head of the Insurance and Pensions Unit in the European Commission. It was clear from our discussions that there were many good things to explore in pursuit of a closer relationship between the two bodies. Mr van Hulle is a keynote speaker at the meeting of AIDA Europe in London in September 2012.

10.3 Geneva Association

The Geneva Association is a very important part of the international insurance industry. It is the highly respected think-tank of the general insurance sector. We have been having preliminary discussions with the Geneva Association about working together in the area of climate change, particularly as regards long tail insurance.

10.5 Canadian Bar Association

AIDA once had a National Chapter in Canada. It has not had a National Chapter for some years. Recently we opened discussions with the Chairman of the Insurance Law Section of the Canadian Bar Association. Those discussions are at an early stage, but we are hopeful that both organisations may see sense in working more closely together in appropriate ways and areas.

11 WORLD CONGRESS 2014 - ROME AND FLORENCE

- 11.1 The next World Congress will take place in the two Italian cities of Rome and Florence over the period 28 September to 2 October 2014.
- The format of the Congress in 2014 will be new. We are moving away from the traditional format. Consistent with what has been, the Italian Chapter has nominated a principal theme on which it will work. That theme is 'Transparency and Insurance'. The reporter is Professor Giovanna Volpe Putzolu, and the questionnaire to National Chapters will be distributed shortly.
- Instead of a second theme being nominated by the Presidential Council of AIDA, there will be four topics, more like a traditional conference or seminar. These four topics are likely to be:
 - 11.3.1 Discrimination
 - 11.3.2 Preventative Measures
 - 11.3.3 On-line Insurance
 - 11.3.4 Insurance and Arbitration



11.4 The Chair of the Italian Organising Committee is Professor Paolo Montalenti.

12 WORLD CONGRESSES IN 2018 AND 2022

12.1 The proposed locations for the 2018 and 2022 World Congresses are Rio de Janeiro and Cape Town respectively.

13 SCIENTIFIC COUNCIL

- One of the objectives I set at the meeting in Paris in 2010 was the creation of a Scientific Council of AIDA to ensure the quality, relevance, and timeliness of the scientific work of all AIDA organs. That includes the Presidential Council work, the Working Parties, the National Chapters, the Regional Groupings, and of course the content of World Congresses.
- The membership of the Scientific Council has now been settled. Its Chairman is Professor Jerome Kullmann and its Deputy-Chairman is Professor Herman Cousy. Other members of the Scientific Council are Angelica Carlini (Brazil), Samantha Traves (Australia), Wenhao Han (Hong Kong), Birgit Kuschke (South Africa) and Robert Merkin (UK).

14 FINANCE

14.1 Finance Committee

- 14.2 The Finance Committee is made up of the following people:
 - 14.2.1 Taisto Hujala, Chairman
 - 14.2.2 Michael Gill (ex officio)
 - 14.2.3 Colin Croly (ex officio)
 - 14.2.4 Otto Klob (Treasurer)
 - 14.2.5 Peggy Sharon (Israel)
 - 14.2.6 Sergio de Mello (Brazil and President of CILA)
 - 14.2.7 Yves Hayaux du Tilly (Mexico)
 - 14.2.8 Manfred Wandt (Germany)
- 14.3 Generally, the Committee has responsibility for the consideration of all financial issues for AIDA and for making recommendations to the Executive Committee and the Presidential Council either based on requests from those bodies or self initiated by the Committee.
- 14.4 At present, the Committee's principal role is to give consideration to the following:



- (a) The level of subscriptions
- (b) Exemption from subscriptions including relevant conditions, term of exemption, etc
- (c) A policy for the admission of new Chapters that may require an exemption
- (d) A budget for AIDA
- (e) Funding needs and potential sources

14.5 **Payment of Subscriptions**

- 14.6 Each year the Secretariat sends to each National Chapter a subscription notice for payment of the annual subscription fee. Many National Chapters pay the subscription very promptly. Unfortunately, the Secretariat does spend some time chasing those National Chapters which are slow with their payments. It would help the work of the Secretariat if all National Chapters responded promptly.
- 14.7 Under the AIDA By-Laws, National Chapters can apply for a subscription reduction or exemption. The application must be in writing and must set out details of the reasons for the application. If an application is granted, it will only apply for one year.
- 14.8 National Chapters which do not pay their subscription and do not apply for an exemption run the risk of suspending or losing their membership of AIDA. A number of National Chapters have been removed for this reason in recent years.

15 WEBSITE

- 15.1 Robert Merkin is the Vice President responsible for the website. For the meeting of the Presidential Council in Tel Aviv Professor Merkin's report was tabled and adopted. It is available on the AIDA world website.
- 15.2 The website is seen as one of the most important media for communicating with National Chapters, members of National Chapters, and everyone who uses the web to seek information about insurance law.
- To that end, it is important for National Chapters to well maintain their own websites and provide information to the AIDA Secretariat for appropriate inclusion on the AIDA world website. Likewise for the AIDA Working Parties.


